

ORDINANCE NO. 2020-34

**AN ORDINANCE TO AMEND ORDINANCE NO. 2018-22 BY ADDING SECTION 5 TO  
EXTEND THE POLICE JURISDICTION OF THE TOWN OF LOXLEY**

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LOXLEY,  
ALABAMA, as follows:

**WHEREAS**, on October 29th, 2018, the Town Council of Loxley, Alabama, did adopt Ordinance No. 2018-22 which annexed certain property, described below;

**WHEREAS**, on October 29th, 2018, when Ordinance No. 2018-22 was adopted the ordinance did not expressly indicate the extension of the municipal limits would include extending the Police Jurisdiction of the Town of Loxley, Alabama as required by Section 11-40-10 of the *Code of Alabama* (1975); and

**WHEREAS**, Ordinance No. 2018-22 is hereby amended to include Section 5 as follows:


Section 5. The Police Jurisdiction of the Town of Loxley, Alabama, shall be, and is hereby altered so as to include all of the territory here to before encompassed by the corporate limits of the Town of Loxley, Alabama, and in addition thereto the following described territory, to wit:

53 AC (C) IRR FM NW COR OF SEC 4 RUN S 980.2' TO POB TH NE 26  
0.9'; TH SE 611.9'; TH SE 128.6'; TH SW 420'; TH SE 518.5'; TH NE  
420'; TH SE 267'; TH SE 401' (S), TH S 1026' (S), TH SW 284' (S), TH  
NW ALG I-10 1110' (S), TH N 2160' (S) TO POB SEC 4 - T5S-R4E


The territory described in this ordinance shall extend the Police Jurisdiction of the Town of Loxley, Alabama effective January 1, 2021 pursuant to Section 11-40-10 of the *Code of Alabama* (1975).

**NOW, THEREFORE BE IT RESOLVED**, Ordinance No. 2020-34 is hereby adopted and hereby amends Ordinance 2018-22, to include Section 5 extending the Police Jurisdiction of the Town of Loxley, Alabama effective January 1, 2021.
