ALABAMA, as follows: BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF LOXLEY,

Ordinance No. 2019-15 which annexed certain property, described below; WHEREAS, on June 10th, 2019, the Town Council of Loxley, Alabama, did adopt

Jurisdiction of the Town of Loxley, Alabama as required by Section 11-40-10 of the Code of Alabama (1975); and did not expressly indicate the extension of the municipal limits would include extending the Police WHEREAS, on June 10th, 2019, when Ordinance No. 2019-15 was adopted the ordinance

WHEREAS, Ordinance No. 2019-15 is hereby amended to include Section 5 as follows:

altered so as to include all of the territory here to before encompassed by the corporate limits of the Town of Loxley, Alabama, and in addition thereto the following described territory, to wit: Section 5. The Police Jurisdiction of the Town of Loxley, Alabama, shall be, and is hereby

run West 210 feet to the beginning corner and excepting therefrom however that part of the Public Road lying within the above described lot. 210 feet to a corner; thence run South 210 feet to a corner on the Section line; thence 2, Township 5 South, Range 3 East, run North 210 feet to a corner; thence run East Beginning at the Southwest corner of the Southwest 1/4 of the Southeast 1/4 of Section

Alabama effective January 1, 2021 pursuant to Section 11-40-10 of the Code of Alabama (1975). The territory described in this ordinance shall extend the Police Jurisdiction of the Town of Loxley,

hereby amends Ordinance 2019-15, to include Section 5 extending the Police Jurisdiction of the Town of Loxley, Alabama effective January 1, 2021. NOW, THEREFORE BE IT RESOLVED, Ordinance No. 2020-37 is hereby adopted and
