

ORDINANCE NO. 2022-29

AN ORDINANCE AMENDING ORDINANCE NO. 2019-28

BE IT ORDAINED BY THE CITY COUCIL OF THE CITY OF LOXLEY, ALABAMA,  
AS FOLLOWS:

**WHEREAS**, The City Council adopted "AN ORDINANCE AMENDING AND REPLACING ORDINANCE NO. 2015-09 OF THE TOWN OF LOXLEY, ALABAMA" Ordinance No. 2019-28 on September 9, 2019.

**WHEREAS**, The City Council amended Ordinance No. 2019-28 with the adoption of Ordinance No. 2021-42 on December 13, 2021 to increase certain fees, rates and charges; and

**WHEREAS**, The City Council desires to amend Ordinance No. 2019-28 again to provide for a Non-Payment Fee.

**NOW THEREFORE BE IT RESOLVED**, by the Council of the City of Loxley as follows:

1. The City Council has agreed that Section 2(e) of Ordinance 2019-28 be amended to read as follows:

(e) **Other Water Fees and Charges: Residential, Commercial, Industrial**

Water meter deposit per unit for owner occupied	\$60.00
Water meter deposit per unit for renter occupied	\$125.00
Hydrant meter deposit per hydrant	\$150.00 (Billed in bulk)
Service Charge	\$35.00

2. The City Council has agreed that Section 4 of Ordinance 2019-28 be amended to read as follows:

**SECTION 4. Late Payment.**

- (a) Bills are due on the 10<sup>th</sup> of each month and late by the 15<sup>th</sup> of each month. There shall be a late fee of \$3.00 assessed to each account which is past due and shall be added to the bill if full payment is not received by the 15<sup>th</sup> of each month.
- (b) A Non-Payment Fee of \$35.00 shall be added to the bill for water and/or sewer customers if full payment is not received by noon on the 25<sup>th</sup> of each month.
- (c) Water, sewer and/or garbage customers failing to make full payment by noon on the 25<sup>th</sup> of each month will also be disconnected for non-payment. Services may be reconnected after paying all charges and fees due under this Ordinance.

3. The City Council thus hereby AMENDS Section 2(e) and Section 4 of Ordinance No. 2019-28 as set forth hereinabove.


4. The City Council thus hereby adopts this AMENDMENT to Ordinance No. 2019-28.

5. The City Clerk is directed to note that Ordinance No. 2019-28 has been amended by this Ordinance in the City of Loxley Code of Ordinances.


6. Except as provided herein, all other provisions of Ordinance No. 2019-28 and Ordinance 2021-42 and all other ordinances and Resolutions of the City of Loxley with respect to such rates and the billing and collection thereof shall remain in full force and effect.

7. This ordinance shall become and be effective from and after it shall have been finally adopted and published according to law.


